RBFSL Electoral Rules

1. Framework

Elections are conducted in line with:

- RBFSL Constitution & By-Laws
- Ministry of Sports, Sri Lanka guidelines
- AIMS governance standards
- Sri Lankan Societies Act provisions

2. Election Officer

- Independent officer appointed by Executive Committee, ratified by AGM.
- Must be impartial, experienced, and unaffiliated with candidates.

3. Voter Eligibility

- Only affiliated District associations may vote.
- Each unit has two votes.
- Final list published 28 days before elections.

4. Candidate Criteria

- Citizen of Sri Lanka
- Elected representative of a District unit
- Not a convict or government employee
- Below 70 years of age
- Must comply with Ministry of Sports conditions

5. Election Timeline

1. Notice – 45 days prior
 2. Voter List – 30 days prior
 3. Nominations – 25–20 days prior
 4. Scrutiny – 19 days prior
 5. Withdrawal – 17 days prior
 6. Final List – 15 days prior
 7. Polling & Counting – AGM/SGM
 8. Results – Same day
- Secret ballot only, no proxy voting.

6. Term Limits

- President / Secretary General / Treasurer – 2 years, max 2 consecutive terms + cooling-off.

7. Transparency

- Election details, results published on official website & social media.
- Records archived and submitted to the Registrar of Sports and International Federation.

8. Inclusivity

- At least 30% women representatives.
- At least 30% athlete representation in the Executive Committee.

9. Dispute Resolution

- All disputes handled by the RBFSL Arbitration Committee.
- Appeals resolved within 30 days.
- Jurisdiction: Colombo District Court (only after arbitration).
